**PRIZE**

60 winners will receive \$100 deposited into their Membership Savings Account (5 winners per month for 12 months) The 60 winners will then be eligible to receive an additional \$20 each if they share their winning story on TCCU’s social media, using the hashtag, #tccu65. Winners are responsible for any taxes.

**ELIGIBILITY**

Entrants must have a US SSN to enter/win and have a TCCU account in good standing.  
Monthly drawing eligibility: All TCCU members with a US SSN, automatically receive one entry per account in the monthly drawing. For automatic entry, the par value of one share (\$5) must be on deposit in the Membership Savings account, no accounts can be more than thirty (30) days overdrawn, and no loans can be over thirty (30) days past due. TCCU employees, employee household members, and Board Members of TCCU are not eligible. Monthly automatic entry eligibility requirements must be met by 5:00 pm CST on the last business day of each month to be eligible for the monthly drawing.

**DRAWING PERIOD**

The Drawing Period begins on January 5, 2020 and ends December 5, 2020.

**HOW WINNER IS DETERMINED**

Five (5) winners will be randomly selected each month within the Drawing Period from all eligible entries received during the preceding month. The prize drawings will be conducted by TCCU each month at the TCCU Main Office @ Tarrant County Plaza located at 200 Taylor Street, Suite 215, Fort Worth, Texas 76196 starting January 5, 2020 with the last drawings taking place December 5, 2020. **TO CLAIM PRIZE**
